Your rights and responsibilities as either a landlord or a tenant depend on whether the tenancy is based on a lease or is an at-will tenancy.

Put the request in writing, stating the problem, and requesting prompt correction. You must serve proper notice or notices on the tenant to terminate this rental agreement. Otherwise it has to be specifically stated in the lease agreement. Because these proceedings are so technical, it is wise to have them handled by an attorney. The lease agreement is a binding contract in which you agreed to pay the rent. In Virginia, you can only break the lease legally using the military clause or in cases of abuse; otherwise, it is an agreement reached between tenant and landlord. This code covers items such as plumbing, electric, structure, heat, hot water. The tenant must maintain the dwelling without damage, other than ordinary wear and tear, keep the dwelling clean and maintain the plumbing. Under some circumstances, the tenant may receive the security deposit plus .
